Terms & Conditions

1. Duration of Dance Season

- The dance season is approximately 36 weeks in length

2. Fee Payments

- September fees are due at the time of registration
- All fees are payable no later than the 15th of each and every month classes are in session (with the exception of September fees which are due at time of registration & March fees which are due by March 10th)
- Fees that are late are subject to the following interest charges:
 - Up to 7 days late – 2% interest
 - 7 to 21 days late – 3.5% interest
 - 21 days late or more – 5% interest
- A \$30.00 fee will be charged for all cheques returned NSF, in addition to fees charged to you by your bank.

3. Methods of Payments

- We accept Debit, Visa, MasterCard, American Express, Cheques, and Cash

4. Costume Deposits

- A costume deposit is required for each class the student is registered for:
 - Recreational students
 - \$75.00 deposit per costume
 - Deposit required by November 19, 2011
 - Deposits are non-refundable once the costumes have been ordered
 - Competitive students:
 - \$100.00 deposit per costume
 - Deposit required by October 15, 2011
 - Deposits are non-refundable once the costumes have been ordered

5. Cancellations, Withdrawals, & Refunds

- Students who withdraw prior to the season start are entitled to a full refund
- If a student wishes to withdraw from a class once the season has begun, they must inform the studio office before the 1st of the month in order to receive a partial refund
